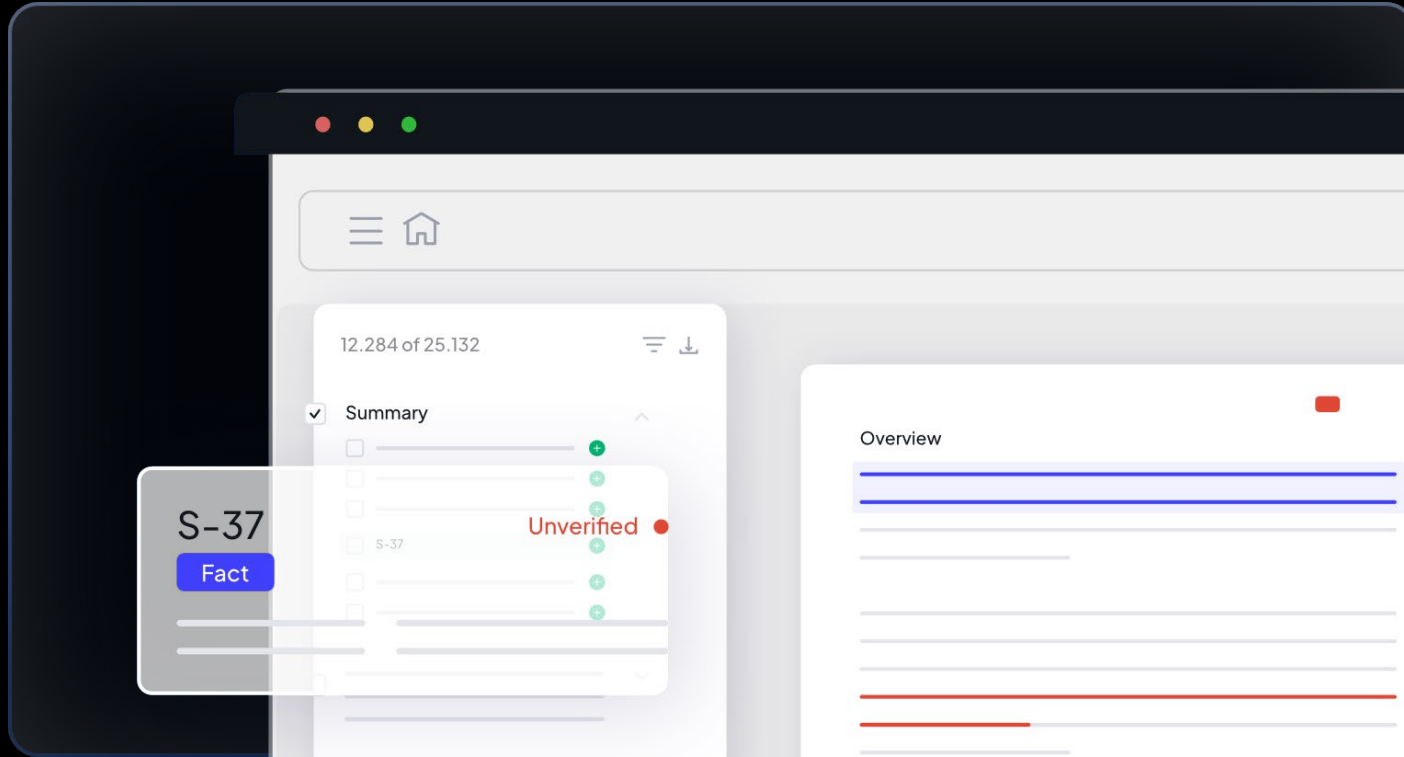

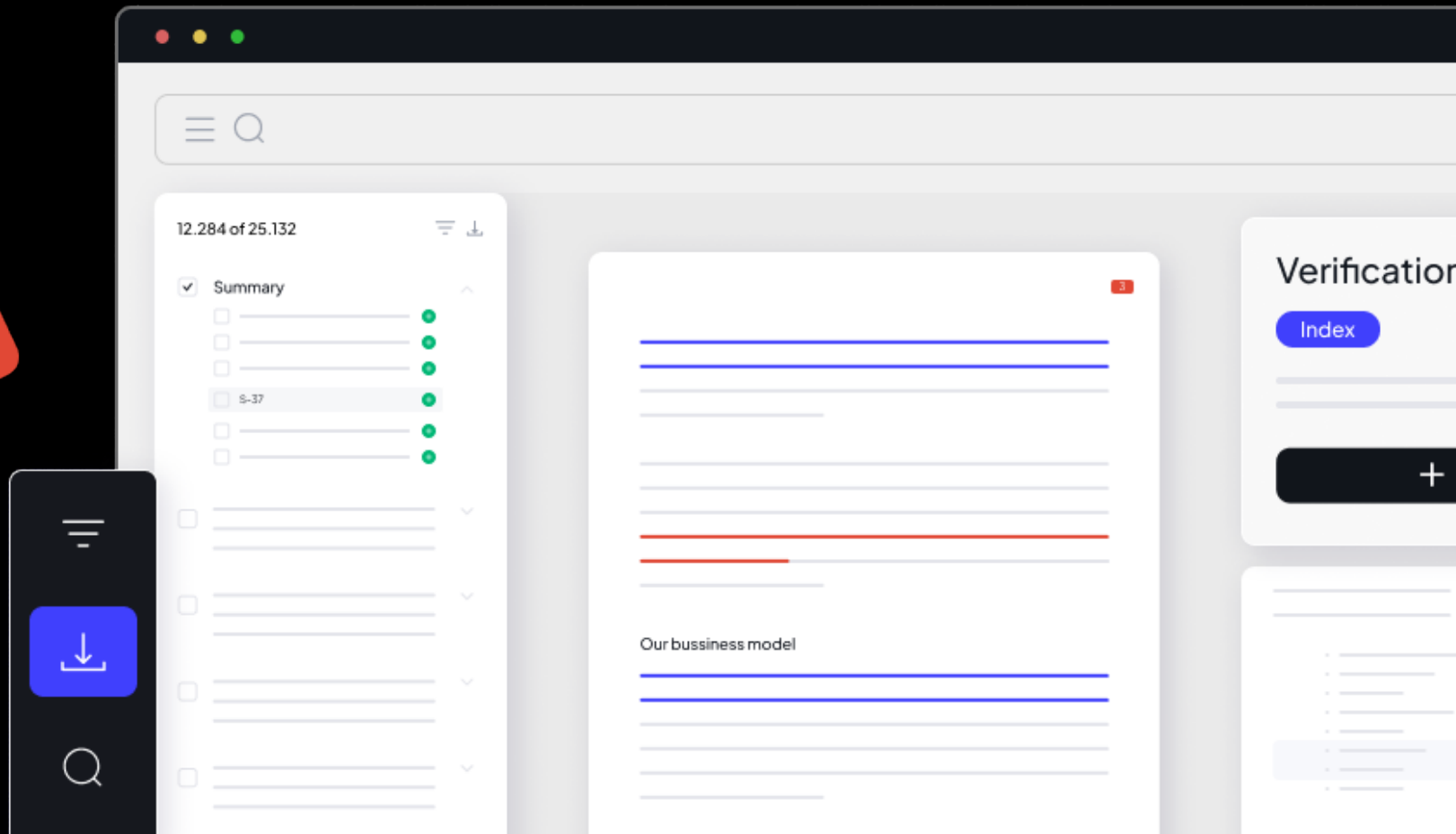

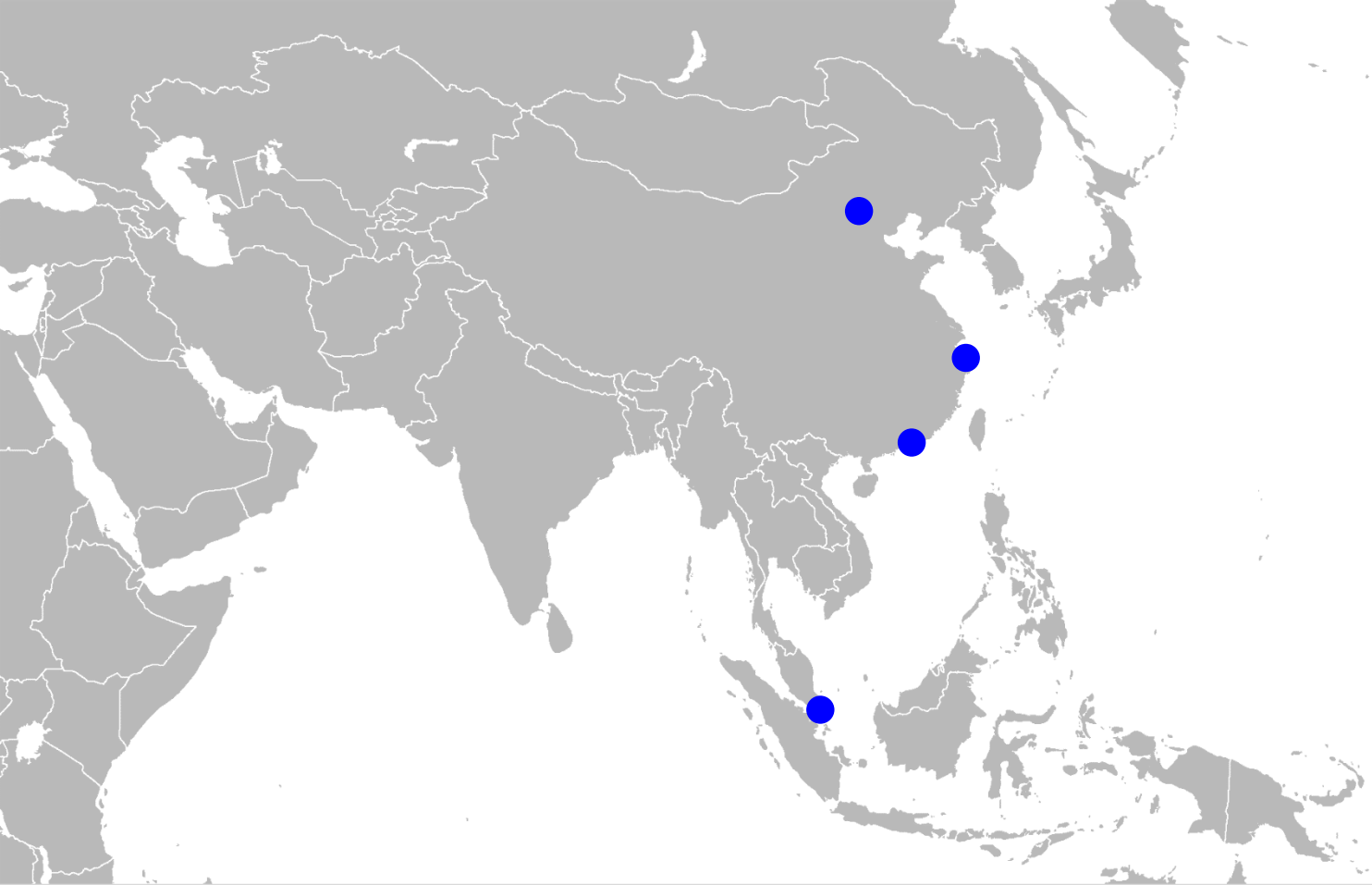

IPO Use Case – Maximum Speed, Security, and Assurance.

01. Prepare

Material statements are identified within the prospectus. Each statement is indexed and referenced with an ID.

45 man-hours → 10 minutes *

02. Verify

Statements are classified as facts and opinions. Directors confirm opinions, while facts are verified using client documents.

165 man-hours → 50 man-hours *

03. Organize

Supporting documents are collected and organized in folders and cited for verification.

40 man-hours → 8 man-hours *

Scale over 10-20 document versions over the entire IPO

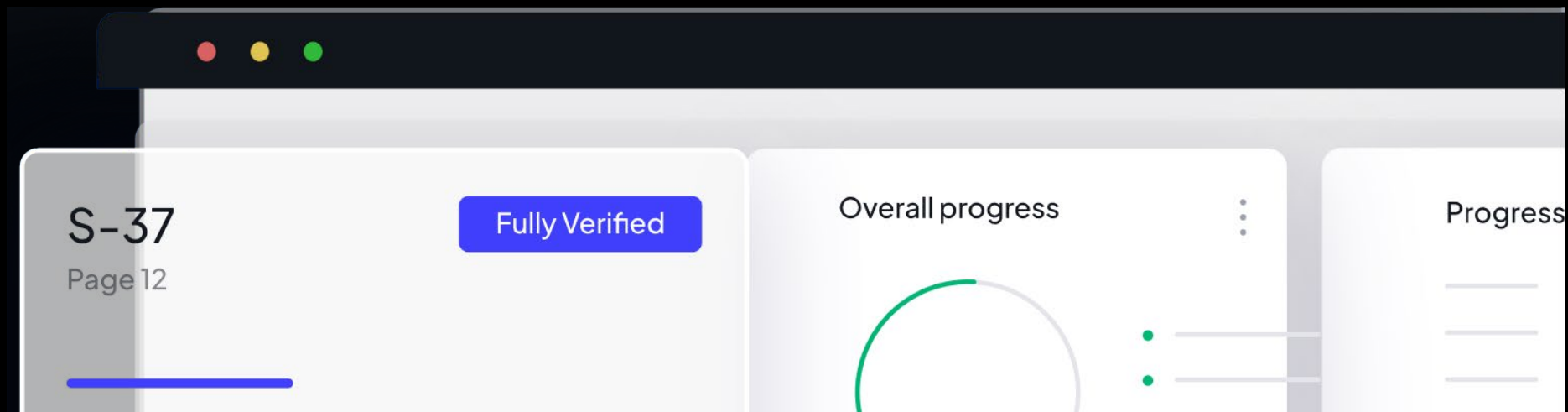

RTO/RPO	✓	High availability zones to ensure RTO/RPO is in minutes
